## HON. DALE ATKINS

The Honorable Dale Atkins received her undergraduate degree from the University of Notre Dame and her law degree from Southern Methodist University School of Law. Following law school, Ms. Atkins went to work as an Assistant District Attorney with the New Orleans District Attorney's office. During her legal career, Ms. Atkins has worked with the law firms, Bryan & Jupiter and Roedel Parsons Koch Blache Balhoff & McCollister.

Since 1989, Ms. Atkins has served as the Clerk of Civil District Court for Orleans Parish. She is the first African-American woman to be elected clerk of a district court in this state.

## THE ROLE OF APPELLATE JUDGES


Appellate court judges do not re-try cases, and they do not hear new evidence. Rather, they review decisions made by the trial courts and raised by the parties.

Appeals in either civil or criminal cases are usually based on arguments that there were errors in the trial's procedure or errors in the trial court's interpretation of the law.
